THE PROBLEM & IMPACT ON PROFITABILITY

As the manufacturing world rapidly shifts into global sourcing in order to optimize costs, legacy ERP systems that were designed mainly to handle the domestic supply chain, fail to keep up with the spiraling complexities.

Various studies by Aberdeen Group as well as Percite's own customers' data indicate that by implementing the SCMaster solution, a typical mid-size manufacturer (~\$200M- \$2B YGR) can achieve save ~1%-2% of COGS, which is translated to profitability increase of 5%-8%.


Unique Value Proposition of SAM (Smart Freight Audit Module) - E-Freight Process

SCMaster SAM automates a tedious and error prone manual freight bills handling and adds workflow control and intelligent engines to the freight bills life cycle. The use of **SCMaster** takes away a layer of manual operations from the logistics, traffic and accounting process resulting in higher efficiency, less errors, increased profits and while seamlessly interacting with the ERP, achieves a dramatic cut of human effort of the auditors involved in this process.

SCMaster manages at the corporate level, a logistics data warehouse, which in turn provides holistic control over global freight expenses and analytics. SAM also has a Document Audit Checker, based on INCO and other configurable rules (User's Configuration). SAM rule base also supports SOX audited process, including document e-archiving and an optional Account Payable posting.

SCMaster SAM is a standard platform with interfaces to the Enterprise ERP system, and its carrier's electronic or automatic feeds. A behind-the-firewall gateway integrates the ERP with the **SCMaster**. **SCMaster** Product Suite has been in production for more than 7 years, auditing over \$50MM of freight x100'000 bills, identifying and reducing over 6% of landed costs overcharges.

CUSTOMERS CASE STUDY – CHAMPION MOTORS

SCMASTER MODULES - SAM, IMPORT, ERP FINANCE (AP) INTERFACES

Champion Motors is the 2nd larger AUTO importer of the Volkswagen Corporation (Volkswagen, Audi, Skoda, Seat) in Israel.

On a yearly basis, Champion manages 40'000 SKU's, which generate thousands of Ocean, Air and Courier inbound

shipments.

Before SCMaster:

Champion Motors suffered from over 5% errors in the landed cost auditing process due to the following reasons:

- Over Charges Debits
- Double Charges
- Mis-calculation by their forwarders, due to bad handling of exchange rates, Fuel & Security accurate rates etc.







After SCMaster:

Champion reached an exceptional 0.0037% error rate as of their automatic Auditing Process.

All Freight Invoices (electronic fed from Forwarders and couriers) are audited and automatically posted in Champion's ERP AP, relieving excessive human resources from doing so.

SCMaster automatically sends dispute reports to the relevant forwarders, reducing man power effort dramatically.

Freight Invoices are ready to be paid to the vendor, in less than 1 day from its receipt. Auditing process cycle is fully logged for long term probing.

Plasan SASA is an armored vehicle Mfg., which produces large amount of kitted vehicles' parts to the US army and others as well.

Plasan is a Project Driven Mfg. and last project was in a ~\$1B magnitude. Plasan has over 600 vendors.

Plasan issues 10'000 POs with more than ~30'000 lines a year.

Before SCMaster:

Plasan suffered in a former \$600M project with excessive \$40M un-allocated inventory – tedious manpower put into the purchasing process and manual management of Importation and Exportation documentation and management (especially with

"drawbacks") and accounting related tasks.

After SCMaster (Supporting \$1B Plasan / US Army project)

Un-allocated inventory went down to unbelievable figure of ~ \$1.5Million – less than a friction of the COGS.

All vendors, in virtually no time, responded their promise date, allowing **SCMaster uploaded them into Oracle EBS ERP**, while re calculating the Actual Receiving Date (Oracle ETA) – as per logistics mapping, thus proving planners much better visibility.

Erroneous Vendor responses (early than allowed or later than allowed or later than the ERP Planning Horizon) were validated and returned to Vendor for better try.

All of freight invoices (inbound and outbound) were electronically captured from forwarders and couriers and posted into ERP AP.

All of Customs Declarations were automatically (EDI) captured and posted into ERP AP for fast VAT reconciliation.

SCMaster repository was disclosed to ERP BI (Oracle's OBEE, SAP's BO) Analytics to give a holistic view of Plasan Supply Chain Costs and other KPI, which are not stored in ERP repository.
